Rice Supply Framework Agreement

This Framework Agreement for the supply of Long Grain Milled Rice in 25kg bags is made and entered into and executed this 16th day of MAY AD 2023 by and between the Ministry of National Defense, represented by the Minister of National Defense, Honorable Daniel D. Ziankahn, Jr. of the city of Monrovia, Liberia (hereinafter referred to as the BUYER) and the ANITA GROUP OF COMPANY represented by its General Manager, Jimmy Emmanuel Flomo, also of the City of Monrovia, Liberia (hereinafter referred to as the SUPPLIER) and collectively for the purpose of this agreement, referred to as the PARTIES.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

WHEREAS, the Buyer has demonstrated and expressed the need for the supply of dry ration (Long Grain Milled Rice) in 25kg specs, and

WHEREAS, the Supplier has presented itself to the Buyer as having the capacity and ability to supply the required quantities and quality of rice and the Supplier has agreed to supply the Buyer with the quantity and quality of the product requested to meet the Buyer's operational need for the duration of this contract.

NOW THEREFORE, for and in consideration of the foregoing the parties agree to the following:

1. That the Supplier agrees to provide the Buyer with Sixty-nine Thousand Eight Hundred Seventy-Six (69,876) bags of 25kg Long Grain Milled Rice at the agreed price of Twenty-Two United States Dollars (USD22.00) during the fiscal year 2023.
2. That the Supplier shall deliver on a quarterly basis (3 months) supply of the specification of Long Grain Milled Rice in 25kg bag to the Buyer starting January 1, 2023 to December 2023.
3. It is mutually agreed between the parties that the Buyer shall make payment of the quantity and quality of dry ration Long Grain Milled Rice supplied by the Supplier through the Government of Liberia Voucher Payment System on a quarterly allotment/disbursement basis upon the submission of the Supplier's invoices and delivery notes for a given month.
4. It is further mutually agreed by the parties that upon the failure of the Supplier to deliver Long Grain Milled Rice in 25kg bags, the Buyer shall notify the Supplier by writing for the first offense. Failure of the Supplier to comply or to remedy the situation, the Buyer shall have the right to abrogate this agreement and enter into an agreement with any other supplier of its choice for the supply of Long Grain Milled Rice in 25kg bags.
5. It is further mutually agreed by the parties that the Supplier shall deliver sixty-nine Thousand Eight Hundred Seventy-Six (69,876) bags of 25kg Long Grain Milled Rice of agreed quality to the Buyer upon the presentation of the approved and sealed Local Purchase Order (LPO) from the Ministry of Finance and Development Planning - MFDP, the GOI.




