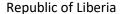

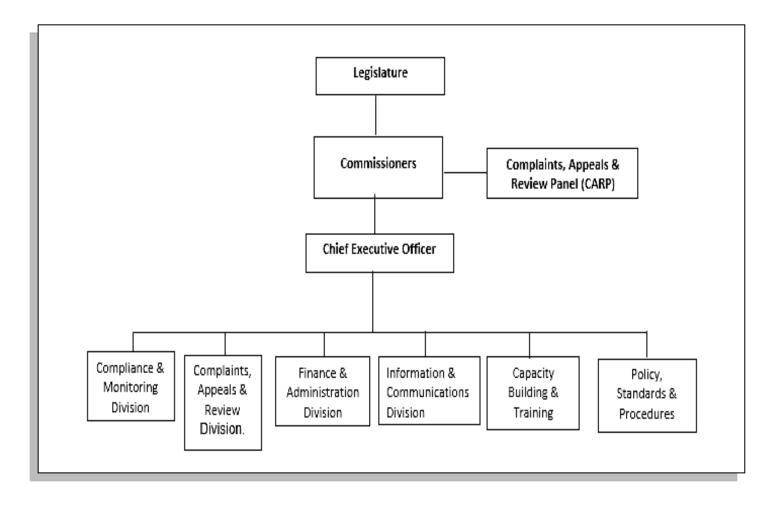

#### 1.0 EXECUTIVE SUMMARY

#### THE PPCC PROFILE

The Public Procurement & Concessions Commission (PPCC) was established in 2006 to oversee all public procurement and concessions processes in accordance with the PPCA 2005 as amended and restated in 2010. The PPCC monitors compliance of all procuring entities with the governing procurement laws, which are stipulated in the Public Procurement and Concession Act of Liberia. The Act regulates all forms of public procurement and Concessions, establishes the Public Procurement and Concessions Commission, provides for institutional structures for public procurement and concessions, and stipulates methods and procedures for public procurement and concessions and for purposes related thereto (PPCA Section 4 and 5).

The importance of adherence to procurement laws is fundamental to any positive reform process in Liberia, as procuring and concession granting entities, meeting up with their obligations to comply with stipulated laws, will yield many benefits that are essential to national development. This report sums up the activities of the Public Procurement and Concession Commission in 2020.

#### ACHIEVEMENTS/PROGRESS IN 2020

#### **ELECTRONIC PROCUREMENT PLATFORM**

The Commission sought and secured funding assistance from the World Bank & African Development Bank for the modernization of public procurement. The work-plans, detailing the activities leading to the establishment of the eProcurement platform, have been prepared, submitted and for the most part, approved by the different partner institutions. Implementation of activities has since commenced, evidenced by the study tour visits to the Republic of Georgia in Eastern Europe, during the month of January 2020, as well as those made to the Republics of Rwanda and Botswana in December 2019. These activities were spearheaded by the Chief Executive Officer. The objective was to derive a robust electronic procurement system in Liberia, with linkages to other online platforms including the Integrated Financial Management Information System (IFMIS), revenue portal of Liberia Revenue Authority (LRA), Liberia Business Registry, amongst others. Series of other activities approved by the World Bank and African Development Bank on the subject matter are under serious implementation consideration. It is anticipated that the successful implementation of these precursor activities will solidify the foundation for the establishment of a robust and user's-friendly eProcurement platform in Liberia.

#### STRATEGIC PLAN

Strategic Planning Developed a Strategic Plan that represents the strategic direction of the PPCC for the next five years, (2020-2024). The Plan is essentially a road-map that provides direction for key undertakings of the Commission during this period. It takes into consideration the development objectives of the Government of Liberia as contained in the National Development Plan (Pro-Poor Agenda for Prosperity and Development (PAPD). This Plan upon finalization and validation will become the basis for annual planning, stakeholders, donor engagements and resource mobilization

#### COMPLIANCE TO THE PPCA

During the year 2020, 146 (One Hundred Forty-Six) Procuring Entities were invited to attend the Annual Procurement Plan Hearing and to submit their procurement plans for review. Out of this total number, 119 or 81.5% showed up and presented their plans to PPCC for review and approval. Based on the reviews, the plans were approved and the entities were given the greenlight to undertake procurement consistent with the approved plans. However, 27 procuring entities or 18.5% did not show up for the exercise as required by Section 40 of the PPCA.

Also, Entities' compliance to Section 27(g) of the PPCA became a serious challenge during the period under review. For the record, only 9 (Nine) entities or 6.1% of the total number of Procuring Entities (PEs) submitted quarterly procurement reports to the Commission. This shows that 136 or 93.9% of the total number of PEs did not report to the Commission on the progress or status of their respective procurement activities as required by the PPCA.

#### CONTRACTS AWARDED IN THE 2019/2020 FISCAL YEAR

For the period July 1, 2019 to June 30, 2020 (Fiscal Year 2019/2020), a total of 158 contractual documents were submitted to the Commission by procuring entities. Such contracts sum stood at \$15,118,545.50. Of the total amount mentioned, \$379,974.00 or 3% were procured under Sole Sourcing arrangements; while \$263,688.80 or 2% were acquired through the request for quotation method. Additionally, 36% or \$5,449,756.46 was spent using Restricted Bidding and \$6,173,932.59 or 41% was expended for goods and services under the National Competitive Bidding (NCB) process; while at least 17% or \$2,585,793.65 of the reported amount was disbursed through the International Competitive Bidding (ICB) process. The rest was expended through various consultancy selection methods, representing 1.4% or \$265,390.

#### Capacity Building and AWARENESS

In November 2020, a One-day Public Procurement Sensitization workshop was convened in Monrovia to foster collaboration with the media and civil society groups aimed at enhancing Liberia's Public Procurement Reform Program. The workshop was attended by sixty (60) professionals and it sought to strengthen the knowledge of journalists on matters relating to public procurement, forge partnership with the media in aiding with the information dissemination mechanism, narrow the existing knowledge gaps of the media and civil society in public procurement. PPCC collaborated with the Open Government Partnership (OGP) Secretariat to conduct the workshop.

#### **VENDOR REGISTER**

In an effort to popularize and sensitize the public and various procurement stakeholders about the existence of the online vendor registration platform and other initiatives, a local artistic group was contracted to produce jingles and dramas to facilitate the information delivery efforts of the Commission. When finalized, the jingles and drama will be aired on several radio stations in Montserrado and other parts of Liberia to support the information dissemination mechanism of the Commission.

In 2020, staff of the PPCC were deployed in several communities within Montserrado County to conduct assessment of businesses enrolled on the vender registration database. The objective was to determine the visibility of businesses and accuracy of information contained in the VR database for update purposes. A total of 578 businesses/companies were visited during the period.

#### **CHALLENGES**

It is noteworthy to state that there has been buttressing support from partners for selected activities. However, on the overall; the Commission is faced with hitches in implementing its key mandates that will generate proactive reform in the public procurement and concession sectors. In reference, the Commission highlights the following challenges:

- ❖ Inadequate budget to fully execute the mandates of the Commission;
- The unwillingness of some public procurement and concession granting entities to comply with the processes and procedures of the PPCA;
- ❖ Insufficient manpower to effectively carryout the mandates of the Commission; and
- ❖ Inadequate office space and equipment/working tools such as laptop/computers, furniture and vehicles to enable the Commission fully perform its statutory responsibilities.

#### **CONCLUSION**

The Commission is exerting every effort and is tapping on every available resource(s) to ensure the achievement of its mandates in an effective and efficient manner. Discussions and interventions with donors and partners' institutions like the World Bank, African Development Bank, as well as the United Nations Development Program (UNDP), are all centered on ensuring that additional support is provided to implement the mandates of the Commission, such as compliance monitoring, capacity building and awareness creation, and policy formulation. Though the Commission has made some strides in the implementation of its core program objectives, the absence of a digitized procurement platform is presenting some serious bottlenecks to the effective and efficient implementation of the Public Procurement Reform Program. This is why the need for the establishment of a robust electronic procurement platform cannot be overemphasized.

#### RECOMMENDATIONS

If the following issues are given serious consideration, remarkable progress can be achieved in the implementation of the Public Procurement & Concessions Act of Liberia:

- ❖ The Government of Liberia through the Ministry of Finance and Development Planning (MFDP) should only make allotment for Goods and Services to agencies that have approved procurement plans in compliance with Section 24 of the Public Financial Management Act. Notice of this legal requirement should be included in the Fiscal Rules.
- The Commission should strengthen the already existing collaboration with the Accounting Services Unit of MFDP to ensure full PPCA compliance before payment is made on any procurement contract; with the Internal Audit Agencies (IAA) to ensure that IAA technicians assigned at various MACs are fully conversant with the procurement compliance requirements; and with the Ministry of Justice to ensure that contracts for attestation by the Minister are fully compliant with the PPCA.
- The Commission should adopt the Name and Shame mechanism to deter the noncompliance posture usually exhibited by some Procuring Entities during the Annual Procurement Plan Hearing exercise.

#### 2.0 INTRODUCTION

The Public Procurement and Concessions Act (PPCA) of 2005 as amended and restated in 2010 established the Public Procurement and Concessions Commission (PPCC) in 2006, to among other things, ensure compliance with the provisions of the Act to whom all it applies. The Commission has the core objective to ensure that public procurement and concessions activities are done in a fair, transparent, competitive and non-discriminatory manner. In compliance with Section 20 (2) and (3) of the PPCA, which states "The Commission shall, not later than the end of each calendar year, publish and submit to the Legislature and the President, a report including:

- The Commission's activities and operations for such fiscal year;
- A copy of the Commission's audited accounts;
- ❖ A report on the complaints, appeals and administrative reviews for the fiscal year and their outcome;
- Recommendations for improvement of procurement of specific areas of goods, works, services, disposals and the Concessions process and the planned program for the implementation of the recommendations;
- Report on the annual procurement forum held by virtue of Section 5(i) in the previous fiscal year;
- ❖ Any general or specific recommendations for improvement of the work of the Commission; and
- ❖ Without limiting the generality of subsections (1) and (2) of this Section, the Commission at the request of the Legislature shall provide periodic reports to the Legislature on the activities and operations of the Commission for the period so requested; this report provides an account of the Commission's activities for the year 2020. In what follows is the detailed report that provides a full coverage of all the major activities implemented by the different divisions and units of the Commission.

#### 3.0 DETAILED REPORT

#### 3.1 OFFICE OF THE EXECUTIVE DIRECTOR

Atty. Jargbe Roseline Nagbe Kowo serves as Chief Executive Officer of the Commission and administers the day to day functions of the Commission in close coordination with:

- Director of Policy, Standards & Procedures;
- Director of Training & Capacity Building;
- Director of Compliance & Monitoring;
- Director of Information Dissemination & Communications;
- Director of Complaints, Appeals & Reviews; and
- Director of Finance & Administration.

The Office of the Chief Executive Officer is staffed with four staff; namely: Chief of Office Staff, Executive Assistant, Research Officer and Secretary.

During the year 2020, the Office of the Chief Executive Officer implemented the following activities, alongside other operational activities as per the mandates of the Secretariat:

#### ELECTRONIC PROCUREMENT PLATFORM

In 2020, the Commission secured funding assistance from the World Bank & African Development Bank to modernize public procurement. The work plans of the Commission, detailing the activities leading to the establishment of the eProcurement platform, have been prepared, submitted and for the most part, approved by the different partner institutions. Implementation of activities has since commenced, evidenced by the study tour visits to the Republic of Georgia in Eastern Europe, during the month of January 2020, as well as those made to the Republics of Rwanda and Botswana in December 2019. The objective was to derive a robust electronic procurement system in Liberia, with linkages to other online platforms including the Integrated Financial Management Information System (IFMIS), revenue portal of Liberia Revenue Authority (LRA), Liberia Business Registry, amongst others. Series of other activities approved by the World Bank and African Development Bank for the sole purpose of establishing an electronic

procurement platform in Liberia are being implemented by the PPCC. The following activities have been launched and are ongoing:

#### 4.0 DIVISIONAL REPORTS

#### 4.1 FINANCE AND ADMINISTRATION DIVISION

The Division of Finance and Administration is the custodian of the Public Procurement and Concessions Commission's (PPCC) assets, both financial and fixed while ensuring proper accounting and internal control systems. The Division comprises several units, namely:

- Human Resource
- Procurement,
- ❖ Information Technology(IT), and
- Maintenance

#### The functions of the Division include:

- Managing and operating the accounting systems of the PPCC to ensure the accountability of staff transacting business and facilitating the efficiency of the transactions;
- Ensuring that the PPCC financial management system is compatible and consistent with the GoL treasury financial management system;
- Ensuring the efficient and effective use of appropriations under the control of the PPCC in compliance with enactments and/or regulations issued under the authority of any enactment;
- Ensuring that all books of accounts under the control of the PPCC are correctly posted and kept up-to-date;

- ❖ Producing, when required by the MFDP, the IAU, the AG, or other Authorized Officers, all cash, books, records, vouchers or other items of value in the charge of the PPCC; and
- ❖ Managing and reconciling the bank accounts authorized for the PPCC;
- **Exercising oversight over donor-funded project accounts, etc.**

During the FY2020/2021, the total appropriation amounted to US\$752,754 based on the ceiling provided to the Commission by the Ministry of Finance and Development Planning. This amount is broken down as follows: Compensation of Employees US\$721,253 and Goods and Services US\$31,501.00.

#### **BUDGET PERFORMANCE OVERVIEW**

However, during the reporting period, the Commission received the total amount of US\$789,939.35 representing the last two quarters in FY 2019/2020 and the first two quarters in FY 2020/2021. Compensation amounted to US\$691,993.15, representing 87.60%, while goods and services amounted to US\$97,946.20, representing 12.40%.

#### **BUDGET PERFORMANCE**

During the year under review, five members of the PPCC staff were retired following years of service to the Government of Liberia. The retirement is in keeping with the Standing Orders of the Civil Service Agency. As a result of the retirement, the PPCC compensation package was reduced from US\$721,253 to US\$691,993.15.

#### ACTIVITIES COMPLETED FOR THE PERIOD

During the reporting period, the Division completed the following activities;

- Prepared quarterly reports (3<sup>rd</sup> and 4<sup>th</sup>), and the Annual Financial Report for 2019/2020
- Prepared Fiscal Year 2020/2021 First Quarter Report
- Prepared Fiscal Year 2020/2021 Budget
- Planned and participated in Public Financial Management Workshop for the Finance Office and other Departments of the Commission
- Coordinated with other Departments/Units for the smooth operation of the Commission

#### 4.1.1 HUMAN RESOURCE UNIT

The Human Resource Unit is charged with the responsibility to coordinate all personnel activities of the Commission. This report is centered on its activities for the period under review.

#### 4.1.2 PROCUREMENT UNIT

#### Introduction

The Procurement Unit is charged with the responsibility to conduct all procurement activities on behalf of the Commission consistent with requirements of the Public Procurement and Concession Act of Liberia (PPCA-Section 29). The Unit plans and sources the supply of quality goods, works and services for the Commission through appropriate procurement methods. It works under the supervision of the Division of Finance and Administration, and it is staffed with two persons; a manager and procurement officer.

#### SUMMARY OF PROJECT AND GOL FUNDED PROCUREMENT ACTIVITIES

During the period under review, the Commission acquired goods and services amounting to Sixty-Two Thousand Five Hundred Forty-Four United States Dollars and Sixty-Five Cents (\$62, 544.65). The total procurement expenditure incurred for SBA amounted to US\$ \$27,566.35 or 44%, whilst NON-SBA procurement expenditure stands at US\$ \$34,798.65 or 56%. There was no procurement expenditure financed by donors during the period under review.

#### **PROSPECTS**

In the next few years, the PU seeks to establish itself as a leader in the practical application of the principles of procurement as enshrined in the PPCA and other accepted international best practices. However, this can only be achieved through the full support of the Commission through the PC in pursuit of the overall organizational goals.

#### 4. 2. COMPLIANCE & MONITORING DIVISION

#### **INTRODUCTION**

The Division of Compliance & Monitoring is charged with the responsibility to monitor compliance of procuring and concession entities with the procedures under the law and regulations established by the PPCC; review procurement and concession documents and/or inspect records as necessary and prevent corruption of the process or any intended process; investigate public and private entities as necessary where there are allegations or suspicion that these entities have neglected their obligations under the law;

maintain a list of bidders or entities that have been debarred from public procurement or concessions; provide information to be published in the Public Procurement and Concessions Bulletin as required.

#### ACHIEVEMENTS

During the year under review, the Division of Compliance and Monitoring made the following achievements:

#### COMPLIANCE WITH PROCUREMENT PLANNING

During the Fiscal Year 2019/2020 and reporting period, 146 Procuring Entities were invited to attend the Annual Procurement Plan Hearing and to submit their annual procurement plans for their respective core budgets as contained in the 2019/2020 approved National Budgets and the approved budgets of States Owned Enterprises (SOEs). Out of this total number, 119 or 81.5% annual procurement plans were approved by the Commission. This means that 27 or 18.5% of the total number of Procuring Entities (PEs) did not have approved procurement plans.

Comparing the total number of PEs of 119 with approved annual procurement plan during the 2019/2020 FY with that of the total number of PEs of 84 with approved annual procurement plan during the 2018/2019 FY, 35 or 41.6% additional PEs annual procurement plans were approved during the 2019/2020 FY.

Though having an approved procurement plan does not translate into full compliance with the PPCA, but it expresses an intention on the part of a PE to comply with the requirements of the PPCA by submitting its annual procurement plan for approval. In contrast, executing procurement activities without an approved procurement plan exposes procurement activities to flaw and mis-procurement that could result in the misappropriation, misapplication and underutilization of scarce public resources. To this end, all the entities that implemented procurement activities without an approved procurement plan put the fraction of the 2019/2020 National Budget allocated to them at risk. The listing of entities with and without approved procurement plans for the FY 2019/2020 is provided in annexure 1 of this report.

It is worthwhile to report that 38 or 26% of the total number of PEs mentioned above also submitted project procurement plans that were approved by the Commission. The listing of entities that submitted project procurement plans is provided under annex 2 of this report. (Please see Appendix A: Approved Main Line & SOE's Procurement Plans for FY 2019/2020).

#### SUBMISSION OF QUARTERLY PROCUREMENT REPORT

Section 27 (g) of the PPC Act requires the Procurement Committee (PC) of every procuring entity to provide the Commission with quarterly reports. For this reporting period, only 9 or 6.1% of the total number of entities submitted quarterly procurement reports to the PPCC as required by section 27 (g) of the PPC Act. This means that 136 or 93.9% of the total number of PEs did not report to the PPCC on the progress or status of their respective procurement activities. This non-complaint posture stalled the review process and presented some difficulties in determining whether or not they conducted their procurement activities in line with the PPC Act. The listing of non-compliant entities in this category for 2019/2020 is provided in annex 3 of this report.

#### SUBMISSION OF QUARTERLY REPORTS

Section 37 of the PPCA and Section 9 of the Schedule of Threshold on Procurement Regulation No.003 require that procuring entity shall promptly furnish the Commission with information on every contract award in which the price exceeds US\$20,000.00 for goods; US\$10,000.00 for services and US\$30,000.00 for works. It particularly requires the indication of the reference number, contract price, name and address of the successful bidder, a brief description of the goods, services or works procured and the procurement method utilized in awarding the contract. For the period under review, only 9 or 6.1% of the total number of Entities provided information to the Commission regarding contracts awarded above the stipulated thresholds. This means that all other Entities that awarded contracts for goods above US\$20,000.00, services above US\$10,000 and works above US\$30,000 did not provide their contract award information reports to the Commission for review and subsequent publication as required by the PPC Act (Please see attached Table 4.1 in Appendix D on Quarterly Reports).

#### No Objection Approvals, Queries and Rejections in F/Y 2019-2020

The PPC Act provides that except in the case of emergency and with the prior approval of the Commission, the Procurement Committee shall deliver to the Commission a notice of intent to award a contract exceeding US\$200,000 for Goods, US\$100,000 for Non-Consulting Services, US\$100,000 for Consulting Services without soliciting Expression of Interest, US\$200,000 for Consulting Services following the solicitation of Expression of Interest, and US\$400,000 for Works. No Procuring Entity shall enter into a procurement contract above the Thresholds established by Regulations promulgated by the Commission unless a minimum of fourteen (14) days have lapsed since the notification of intent to award a contract was delivered to the Commission.

During the period under review, 25 (twenty-five) or 17.1% of the total number of PEs sought the "Prior Approval" of the Commission to award 38 contracts for Goods, Works and Services in excess of the thresholds stipulated under Section 7 of the Schedule of Threshold (Reg. No.003). Of the 38 requests for "No Objection" to award contracts that the Commission received during the FY under review, 34 or 89.4% were approved and 4 or 10.6% were queried. The percentage of queried requests shows that there are still institutions that are not conducting procurement activities in keeping with requirements of the PPCA (Please see attached Appendix E: Requests for "No Objection" to Award Contract).

#### 4. 3 INFORMATION & COMMUNICATIONS DIVISION

The Division of Communication is charged with the responsibility to disseminate information related to the Act such as the development and publication of the quarterly Public Procurement and Concessions Bulletin, managing Public Relations on behalf of the Commission, and publishing the annual report of the Commission, amongst others. During the year under review, the Division made the following achievements/representations:

#### MEDIA & CSOs ENGAGEMENT WORKSHOP

In November 2020, the Public Procurement & Concessions Commission received funding from the Government of Liberia to sensitize journalists and representatives of civil society organizations about the rules governing the conduct of public procurement in Liberia. It was also intended to strengthen their reportage on matters related to public procurement. The session was held at the iCampus facility located on Carey Street in Central Monrovia. A total of sixty (60) journalists (editors and reporters) and civil society representatives attended the workshop. Some heads and representatives of international institutions including Embassy of Sweden, United States Embassy, and United Nations Development Program, attended the opening session and made separate remarks. PPCC collaborated with Open Government Partnership (OGP) to conduct the workshop, held on November 3, 2020, on the theme:

"COLLABORATING WITH THE MEDIA TO STRENGTHEN PUBLIC PROCUREMENT INFORMATION CONVEYANCE FOR NATIONAL DEVELOPMENT.

#### DONOR FUNDED ACTIVITIES (E-GP PROJECT)

The Commission is working along with stakeholders to establish an electronic procurement platform in Liberia, and is currently working on series of preliminary activities approved by the donors (World Bank and African Development Bank). Key amongst activities being pursued under the donor assistance portfolio include revision of the PPC Act, 2010 to concur with the public procurement modernization effort, development of Strategy and Business Process Reengineering (BPR), as well as conduct of procurement processes to enhance institutional support for the E-GP project.

#### **UNDP FUNDED PROJECTS**

During the period under review, the PPCC joined the United Nations Development Program (UNDP) and other institutions to develop the Country Program Document for Liberia. The document attempts to address the issue of inclusive governance and seeks to support the Liberian Government improve the quality of democratic governance-legal and policy frameworks, systems, institutions, and capabilities required to deliver essential services to the population. As part of the operating portfolio, the Commission will be strengthened to reduce corruption in Liberia. This initiative will be done through training interventions to be able to prevent and investigate corruption cases. A work plan detailing activities earmarked for implementation in the first year (2021) was developed, approved and submitted to UNDP. The activities concur with the objectives of Liberia's national development plan, namely, <u>Pro-Poor Agenda for Prosperity and Development</u> (PAPD).

#### **INCREASING AWARENESS**

The Commission has developed a set of jingles and drama through a local artistic group to educate the public and different stakeholders on the public procurement implementation reform program as well as some of the new strategies/initiatives developed by the PPCC to enhance public procurement. This is intended to create more awareness to the public about the available public procurement opportunities and the results thereof. Also, scripts writing and editing of PPCC's official newsletter, 'Alert' have been completed and is pending publication. The Alert contains interesting articles and major information about PPCC's activities to include contracts awards information and capacity building interventions.

#### MONITORING AND REVIEW OF PROCUREMENT NOTICES

This engagement is an integral part of the Division because of its role in gathering relevant procurement information from the print and electronic media. The Division has been able to keep up with the monitoring and review of anomalies in the procurement notices published in local dailies by Ministries, Agencies and Commissions (MACS) and other information related to public procurement. These reports are analyzed in consultation with the Compliance and Monitoring Division for onward submission to the Chief Executive Officer's office.

#### 4. 4 POLICY, STANDARDS AND PROCEDURES DIVISION

#### Introduction

The Policy, Standards and Procedures Division (PSPD) is charged with the responsibilities to develop rules, instructions, regulations and related documentations on public procurement and concessions processes and procedures including designing formats in furtherance of the PPC Act 2010. This report is the 2020 Annual report on the division's administrative and operational activities.

#### REGULATION TO REVIEW OR REJECT UNSOLICITED CONCESSION BID

In an effort to curtail influx of requests for no objection by concession entities to accept unsolicited concession bids as the basis for granting concessions, and in fulfillment of the PPCA Section 101, which requires the Commission to

adopt regulation to provide for the procedures for accepting unsolicited bids as the basis for negating concession agreement, the Division of Policy in collaboration with the Division of Compliant, Appeal and Review completed the development of a draft regulation to guide Concession entities in accepting unsolicited bid and is pending approval.

#### Memorandum of Understanding

As part of effort to strengthen the procurement capacity of procurement professionals, the Commission engaged independent procurement schools (vocational, universities/colleges to form and implement collaborative frameworks to develop procurement capacity and expand employment opportunities both in and outside of Liberia for graduates from the Procurement and Supply Chain Management programs in Liberia. The Commission concluded the Memorandum of Understanding with the United Methodist University (UMU) and an understandable working framework with the University of Liberia to develop procurement capacity.

#### DEVELOPMENT OF THE STRATEGIC PLAN FOR THE PPCC

A Strategic Plan was developed to guide and direct PPCC for the next five years (2021-2025). The draft was completed and is pending approval. The auxiliary plans, the Procurement and Resource Mobilization Strategies are under development.

#### 4. 5 COMPLIANTS, APPEALS & REVIEW DIVISION

The Complaints, Appeals and Review Division is charged with the responsibility to:

- ❖ Coordinate all legal matters of the Commission
- Provide legal guidance to the Secretariat
- Represent the Commission in all legal matters
- provide technical, research & secretariat support to the Complaints, Appeals and Review Panel (CARP)
- Receive and advise on all complaints, appeals or requests for review;

A new recruitment process was instituted for the CARP, in newspapers, the PPCC and executive mansion websites. There were 23 applicants, and 14 was shortlisted for interview and 10 were shortlisted finally and submitted to the President in line with procedures for a Selection of five panel members in consonance with PPCA, Section 10 of the PPC Act.

#### **LEGAL DIVISION**

The Division, working along with Compliance Division, received and reviewed the following complaints in line with PPCA Section 11.

- ❖ SEGAL vs. RIA the matter was investigated and amicably resolved.
- Universal Press Corporation(UPC) vs. Liberia Immigration Service (LIS) the matter was investigated and disposed of;
- Wilder Import & Export vs. NPA- the matter has been investigated and pending resolution;
- ❖ M-Tosh vs. NEC- the matter was resolved with instruction to M-Tosh to exhaust the complaint mechanism beginning with NEC.
- Liaised with the Chief Executive Officer and Chairman of the Board of Commissioners to counter the enactment of a parallel procurement act advanced by the Ministry of Health.

#### 4.6 VENDORS REGISTRATION UNIT

#### Introduction

The Vendor Registration(VR) Unit is charged with the responsibility to process/register all businesses and consultants that desire to obtain contract from the Government of Liberia, upload all registered businesses on the PPCC Online Vendors Register, update vendors' data on an ongoing basis, and monitor interested businesses listed in the VR database.

#### UTILIZATION OF VR DATABASE

During the period under review, various procuring entities were able to utilize the Vendors Register to identify and invite old and new potential suppliers when conducting public tendering, most especially, restricted bidding and sole source procurements thereby reducing their procurement timeframes. Also, many informal and non-compliant businesses were caused to formally register and start paying taxes to Government.

#### ASSESSMENT TOUR

Teams of PPCC staff were deployed in several communities within Montserrado County to conduct assessment of businesses enrolled on the vender registration database. The objective was to determine the visibility of businesses

and accuracy of information contained in the VR database for update purposes. The tours took the teams to several communities in Central Monrovia, Sinkor, Congo Town, Paynesville, Bushrod Island, Somalia Drive, Duala, Brewerville, Virginia, etc. A total of 578 businesses/companies were visited during the period.

#### Applications Received and Processed

Several private sector businesses took advantage of the opportunities presented by the VR and submitted their documents for review and enrollment in the VR database. The table below summarizes the number of packages received and processed during the period under review:

**Note:** The 578 registered businesses comprise 431 Liberians, 146 Non-Liberian businesses and 1 International NGO; and by gender comprise 462 males, 82 females, and equal sex, 34.

#### 5.0 CHALLENGES

It is noteworthy to state that there has been buttressing support from partners for selected activities, however, on the overall; the Commission is faced with hitches in implementing key mandates of the institution that will generate proactive reform in the public procurement and concession sectors. In reference, the Commission highlights the following challenges:

❖ Inadequate budget to fully execute the mandate areas of the Commission;

- The unwillingness of some public procurement and concession granting entities to comply with the processes and procedures of the PPCA;
- ❖ Insufficient manpower to effectively carryout the mandate areas of the Commission; and
- ❖ Inadequate office space and equipment/working tools such as laptop/computers, furniture and vehicles to enable the Commission fully perform its statutory mandates.
- ❖ Failure of procuring entities to submit their procurement plans to the Commission as required by Section 40 of the PPCA

#### 6.0 CONCLUSION

The Commission is exerting every effort and is tapping every available resource to ensure that its mandate is achieved in an effective and efficient manner. Discussions and interventions with our donor partners like the World Bank, African Development Bank, as well as the United Nations Development Program (UNDP), are all centered on ensuring that additional support is provided to fully implement the mandate areas of the Commission, such as compliance monitoring, capacity building and awareness creation, and policy formulation. Though the Commission has made some strides in the implementation of its core program objectives, the absence of a digitized procurement platform is presenting some serious bottlenecks to the effective and efficient implementation of the public procurement reform program. This is why the need for the establishment of a robust electronic procurement platform cannot be overemphasized.

## 7.0 RECOMMENDATIONS

The Commission notes that, if the below issues are given serious consideration, remarkable progress can be achieved in the implementation of the Public Procurement & Concessions Act and enormous improvement of Liberia' Public Procurement System of Liberia:

- 1. The Government of Liberia through the Ministry of Finance and Development Planning(MFDP) should make allotment for Goods and Services to agencies that have approved procurement plans in compliance with Section 24 of the Public Financial Management Act. Notice of this legal requirement should be included in the Fiscal Rules.
- 2. That the Commission be provided continuous required financial support to facilitate the execution of its monitoring and review mandate of public entities and subsidized institutions;
- 3. Expansion or relocation of the Commission to accommodate existing staff, other units relevant to the functions of the Commission and create training space;
- 4. Continuous Support by the GOL for provided for the implementation of the eProcurement establishment.
- 5. The National Legislature should provide budgetary support to the Commission to implement the capacity building mandate as required

Sections 27 (g) and 43 (9) of the PPCA require that Procuring Entities should furnish the Commission on a quarterly basis a report for monitoring and evaluation purposes of the contracts awarded during the preceding period. For the reporting period under review, in accordance with the table above, of the one hundred and forty-five (145) procuring entities that received monies for goods and services in the 19/20 approved budget, only nine (9) or 6.2% of the total number of procuring entities submitted a report as required by Sections 27 (g) and 43 (9) of the PPCA for either one (1) of the four (4) quarters of the reporting period. This means that one hundred and thirty-six (136) or 93.8% of the Procuring Entities did not comply with the requirements of Sections 27 (g) and 43 (9) of the PPCA respectively. It is worth mentioning that the failure of the non-compliant entities to submit their quarterly procurement reports as required denied the Commission the possibility of monitoring their compliance with the PPCA regarding the signing and awarding of contracts.
