Foreword

Welcome to our FY2023 first and second quarters report on public procurement institutions compliance to quarterly procurement reporting.

2023 has been an elections year where presidential, senatorial and representatives' elections were held. During such period, preparedness for possible transitions in the Executive and Legislative branches of government had impacted public procurement for many procuring entities who complained the lack of budget to conduct the basic affairs.

It has been a wonderful, though at time tedious, working with around 136 entities in government to ensure they comply to their responsibility to submit quarterly report of their procurement activities.

Entities must report of approved procurement activities in each quarter of the year; January – March, April – June, July – September and October – December. Reports are expected to be submitted at least a month following the closure of the quarter being reported on; however, due to elections as well as other causes, PEs were only able to improve slightly with the Commission's projected 50% benchmark.

It is my outmost pleasure to present this report which captures information on entities' compliance to the PPCA 2010, Sections Section 27(g), 43(2 a-l) and 43(9).

We are hopeful that the next reporting period will reflect more positive growth in compliance to the achievements made in these quarters under review.

Introduction

During 2023, the Public Procurement and Concessions Commission (PPCC) embarked on an exercise to identify all public and government subsidized entities expected to receive budgetary support from the 2023 approved National budget. One hundred and Thirty-six (142) institutions were identified. State-Owned Enterprises (SOEs), included in this estimate, had cash flows from internally generated revenues independent of the National budget modalities.

The 136 procurement entities were evaluated to be in compliance with quarterly reporting base on their positive responses to Section 27(g) of the PPCA 2010 and to the PPCC call circular distributed for this purpose as well as adherence to the numerous reminders through telephone calls, emails and visitations.

This report highlights a summary of the data collected from individual entity's submission in 2023 and how such information reveals overall compliance to the PPCA 2010.

Compliance to Procurement Structures

In accordance to Part 3, sub-part 2 of the PPCA 2010 requires public procuring entities to establish permanent procurement structures at their entities. Two such structures include the procurement committee and the procurement unit. In 2023, majority of ministries, agencies and commissions claim that these structures are established and functional; however, based on the fact that such entities did not submit updated staff and officers' listings of their current structures, and considering that these structures did not submit annual procurement plans, request for no objection and/or quarterly reports to the Commission, such structures as stipulated by Section 26 – 29 of the PPCA 2010 are deemed dysfunctional and not in compliance with established law. Of the 136 procurement entities, 112 were in compliance to the establishment of functional procurement structures (Procurement Committees and units) while 24 were adjudged not to have functional structures. Such condition may have led to noncompliance in other areas of the law including accountability through quarterly reporting.

Compliance to Procurement Planning

This report narrates the directives as outlay in the submission of annual procurement plans for approval as enshrine in Section 40 (3) of the PPCA. Therefore, during the Fiscal Year 2023, out of the 136 Procuring Entities invited for the annual procurement plan hearing and requested to submit their annual procurement plans for their respective core budgets as contained in the 2023 approved national budgets and the approved budgets of SOEs in keeping with the aforementioned provision of the PPCA, under 70% of Procurement Entities (PEs) had their annual procurement plans approved by the Commission. This means that at least 30% of the total number of PEs did not have approved procurement plans for the FY 2023, consequently, the noncompliance to procurement planning also led to a number of PEs not complying to the quarterly procurement reporting requirement.

Compliance to Public Notices of Contract Award

Thirdly, this compliance account also covers procurement agencies obligation to adhere to the submission of public notices of contract award as mandated by Section 37 of the PPCA. In this light, similar statistics for the 1st, and 2nd quarters of 2023 are recorded. Although the stipulated thresholds as required by Section 37 of the PPCA and Section 9 of the Schedule of Threshold on Procurement Regulation No.003 allow for only awarded contracts for Goods above US\$20,000.00, Services above US\$10,000.00 and Works above US\$30,000.00, the Commission (PPCC) in its drive to be more transparent did not disallowed information being provided below the given thresholds; such decision will give users of the information in this report a more detailed experience.

Compliance to Quarterly Reporting

In 2023, 55 of PEs submitted quarterly reports for the first two quarters representing a compliance of 40.4%. as compared to 52 procurement entities 38.2% for the same quarters in 2022. This increment in compliance reflects an improvement of 2.2% or an additional 3 entities. The Commission had purposed to achieve a 50% or at least 68 PEs being in compliance; however, this could not be realized due to elections activities which impacted public procurement in 2023. Notwithstanding the progress, 81 or 59.6% of public procurement entities remained noncompliant to quarterly reporting following series of engagements. Paramount among these are major large spenders to include: The Ministry of Public Works, the University of Liberia, the Liberia Electricity Corporation, the Paynesville City Corporation, the House of Representative, the Ministry of National Defense, and the Liberia Telecommunication Authority (See table A & B-1-3 for details on compliance).

Key Findings from Submitted Reports

A detailed analysis of data received from the 55 reporting entities revealed some important statistics. **Table 1** reveals that at least 403 procurement contracts were signed from those who submitted reports, while 881 bids were received representing an average of 2.1 bid per signed contracts for the reporting period; this figure does not provide a detailed picture of the actual number of contracts signed since 59.6% of entities did not submit reports for the reporting period. Such number of contracts however shows that in the 1st and 2nd quarters contract value was \$36,959,410.92USD. Total spent on SBA procurement was \$16,900,317.66 or 46% of all procurement spending during the reporting period.

During the period under review, a total of USD\$16,900,317.66 or 46% was committed to Liberian owned businesses under the small business Act. While it is statutorily required that 25% of public procurement be given to small and medium Liberian owned businesses, PEs were able to exceed such amount by 21% with the remainder USD\$19,934,093.08 being contracted under a non-SBA arrangement open to all other eligible businesses (See table 5 for details).

Table 5 in attached annexes shows that of the 403 contracts signed in the 1st & 2nd quarters, only 881 bids were received; Considering a ratio of 2.1 Bids were received per contract signed, such data suggest either PEs are conducting their procurement processes with minimum competition or the private sector are not committing to the bidding processes due to inefficiency in the payment system for work or supplies that are delivered.

The 3 predominate procurement method utilized were the National Competitive bidding method used 95 times and represents 30.7%; secondly, the Restricted bidding method used in 72 bidding processes representing 23.2 percent, and the Request for Quotation method utilized in 76 occasions accounting for 24.5% with a total value of USD\$2,661,829.00. Sole Sourcing was utilized 44 or 14% of the times while ICB was only used 15 times accounting for only 4>8%. Details of other procurement and selection methods used are captured in the attached **annexes in tables 6**.

Table 6 shows that only 18 contracts used single sourcing methods for a total amount contract awarded of US\$550,236 in the first three quarters of 2022. However, the table 12 shows that 116 out of 647 awarded contracts had only one bid. As a result, 98 contracts that are not classified as single sourcing contract received only one bid.
In the first three quarters of 2022, the total number of signed contracts to bid received was 647 contracts to 1,216 total bids received. This ratio represents an average number of 1.9 bids per contract signed. Such shows that the level of competitiveness is a little under 2 bids per procurement bidding process. Therefore, there is a need to rapidly expedite the electronic procurement migration process to ensure increased competition, transparency and equal access to all potential bidders.

Recommendations

- 1. That large spending Ministries, Commission, State Owned Enterprises and Agencies of government are made to comply with quarterly reporting as well as other critical compliance requirements.
- 2. That procurement entities are made to increase transparency and promote the achievement of value for money in their procurement methods and approaches;
- 3. That all entities use the default competitive method of procurement for each procurement transaction, and only use single source procurement method upon PPCC's prior approval since the use of restricted biddings have not yielded the anticipated value for money, and
- 4. That entities not complying to quarterly reporting in this report 2023 and the 2022 reports are recommended for audit by the GAC.
