

Subj: REQUEST FOR "NO OBJECTION" TO AWARD CONTRACT TO AMINATA AND SONS INC. FOR THE SUPPLY AND DELIVERY OF PETROLEUM PRODUCTS

We present our compliments and wish to acknowledge receipt of your communication dated February 7, 2025, which sought the approval of the Commission for the General Auditing Commission (GAC) to award contract to Aminata & Sons Inc. for the supply of Petroleum Products ("the Goods") for a unit price not to exceed three United States Dollars and ninety-one cents (US \$3.91) per gallon for gasoline in coupon and four United States Dollars and twenty-one cents (US \$4.21) per gallon for diesel in coupon.

The Commission upon thorough review of your documentation submitted reveals that the GAC's request was accompanied with adequate documentation and is in keeping with section 31 of the PPCA, 2010. Therefore, the Commission hereby grants an approval to the General Auditing Commission (GAC) to award contract to Aminata and Sons, Inc. for the supply of the "Goods" at a cost not exceeding the estimated cost indicated above.

Please note that all contract which cumulative annual value exceeds the threshold of two hundred fifty United States Dollars (US\$250,000.00) must be sign by the minister responsible for Finance and attested by the Minister Responsible for Justice. The Commission requires that you kindly forward copies of all stipulated contracts upon signing so as to update our records.

The Public Procurement and Concessions Commission admonishes and deems it a priority that you remain in compliance with the PPCA, 2010, as we jointly aspire to achieve transparency, accountability, fairness, equality and ultimately public confidence in our procurement and concessions processes.
