Subj: REQUEST FOR NO OBJECTION TO AWARD CONTRACTS TO OMEGA SUPPLY CHAIN, BESTEL VENTURE, MARCONI AND COMPANY, AND BASHIR BUSINESS CENTER FOR THE SUPPLY AND DELIVERY OF ASSORTED T&D NETWORK PERFORMANCE UPGRADE AND REFURBISHMENT MATERIALS FOR THE FISCAL YEAR 2025.

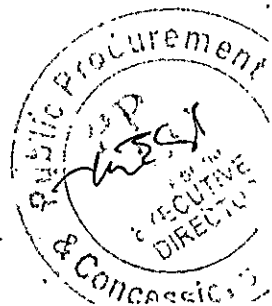
We extend our compliments and wish to acknowledge receipt of your communication regarding the Commission's approval of the Liberia Electricity Corporation (LEC) request, as indicated above.

Upon review of the documentation provided, the Commission wishes to note the following observations:

- ❖ The Liberia Electricity Corporation (LEC) submitted its cover letter, copy of approved procurement plan, evaluation report, bidder's submission, draft contract, and copy of debrief letters to successful and unsuccessful bidders.
- ❖ Further review of the evaluation results indicates the following most responsive bidders for each lot: **Lots 1 and 2: Omega Supply Chain** emerged as the most responsive bidder; **Lots 3 and 5: Bestel Venture** was identified as the most responsive bidder; **Lot 4: Marconi and Company** was ranked as the most responsive bidder, and **Lot 6: Bashir Business Center** was determined to be the most responsive bidder. These selections were based on a comprehensive assessment of compliance with technical and financial requirements as outlined in the bidding documents.
- ❖ An in-depth review revealed that the **total bid price** submitted by all responsive bidders across the six different lots amounted to **US\$3,833,695.00** (Three Million Eight Hundred Thirty-Three Thousand Six Hundred Ninety-Five United States Dollars). In contrast, the total approved amount reflected in the procurement plan stood at **US\$3,552,996.00** (Three Million Five Hundred Fifty-Two Thousand Nine Hundred Ninety-Six United States Dollars), resulting in a deficit of **US\$280,699.00** (Two Hundred Eighty Thousand Six Hundred Ninety-Nine United States Dollars). To address this shortfall, the **Liberia Electricity Corporation (LEC)** made budgetary provisions utilizing savings from a separate budget line titled **"Supply and Delivery of Normmet Connection Materials"**, which was reflected in the updated procurement plan approved by the Commission. This line item showed a **savings of US\$675,969.20** (Six Hundred Seventy-Five Thousand Nine Hundred Sixty-Nine United States Dollars and Twenty Cents), sufficient to cover the deficit without requiring additional budgetary allocations.

This adjustment demonstrates sound financial planning and ensures that the procurement remains within the overall approved budget envelope.



Please be assured, Honorable Chief Executive Officer, that the LEC will continue to diligently adhere to the provisions of the reinstated and amended PPC Act of 2010, along with its accompanying regulations.
