Subj: REQUEST FOR NO OBJECTION TO AWARD CONTRACTS TO OMEGA SUPPLY CHAIN, AND BESTEL VENTURE FOR THE SUPPLY AND DELIVERY OF ASSORTED CABLES, CONDUCTORS, AND ACCESSORIES (UNDER THE CUSTOMER CONNECTION MATERIALS AGILE METERING, ANTI-POWER THEFT OPERATIONS AND GAP PROJECT) FOR THE FISCAL YEAR 2025.

We extend our compliments and wish to acknowledge receipt of your communication regarding the Commission's approval of the Liberia Electricity Corporation (LEC) request, as indicated above.

Upon review of the documentation provided, the Commission wishes to note the following observations:

- ❖ The Liberia Electricity Corporation (LEC) submitted its cover letter, copy of approved procurement plan, evaluation report, bidder's submission, draft contract, procurement committee minutes, copy of bid document, and copy of debrief letters to successful and unsuccessful bidders.
- ❖ Further review of the evaluation results indicates the following four bidders that submitted bids for two (2) Lots;

| 2. | BESTEL | 1,784,720 | 228,598.25 |
| 3. | CITY CENTER | 1,496,600 | 237,369.00 |
| 4. | Marconi & Company | 1,650,600 | 253,016.00 |
| 5. | Bashir Business Center | 1,681,400 | 259,029.00 |

- ❖ However, **City Center** did not provide evidence of similar work completed within the last three years, as required under **Section 4.A of the Post Qualification Requirements (ITB 38.2)**. Additionally, it was observed that **Bashir Business Center** proposed a delivery schedule of **4-8 weeks** in **Section 5 of the Schedule of Requirements**, which does not align with the required delivery timeframe of **5-6 weeks**.

Following these reviews, **Omega Supply Chain** was identified as the most responsive bidder for **Lot 1**, while **BESTEL Venture** emerged as the most responsive bidder for **Lot 2**. It was also observed that the combined total bid price from these two most responsive bidders amounted to **US\$1,712,618.25**, compared to the approved budgeted amount of **US\$2,940,614.00**, thereby indicating a **surplus** for contract award.

From the above findings, the Commission herewith grants the Liberia Electricity Corporation's **No Objection** to award contracts to **OMEGA Supply Chain** for the supply and delivery of assorted cables, conductors, and accessories at the estimated value of **US\$1,484,020 (One Million Four Hundred Eighty Four Thousand Twenty United States Dollars)** for **Lot 1** and **BESTEL Venture** for the supply and delivery of assorted cables, conductors, and accessories at the estimated value of **US\$228,598.25 (Two Hundred Twenty-Eight Thousand Five Hundred Ninety-Eight United States Dollars Twenty-Five Cents)** for **Lot 2** consistent with **Section 31** of the PPCA of 2010:

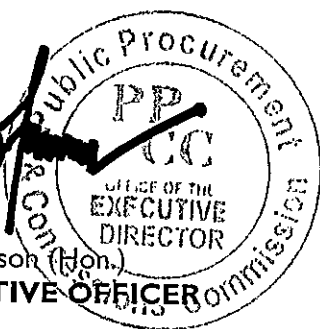
Kindly be reminded that all contracts whose cumulative annual value exceeds the threshold of **US\$250,000.00** must also be signed by the Minister responsible for Finance and attested by the Minister responsible for Justice.
