

WATER TREATMENT CHEMICALS:

We present our compliments and wish to acknowledge receipt of your communication dated May 12, 2025, which addressed queries and sought the approval of the Commission for the Liberia Water and Sewer Corporation (LWSC) to award contract to Family Line Energy for the supply of Petroleum Product ("the Goods") at an estimated cost to not exceed three hundred nine thousand seventh undred seventy-one United States Dollars and sixty Cents (US \$309,771.60) for Lot #1(Bulk Fuel) and Conex Energy for the supply of Petroleum Product ("the Goods") at an estimated cost to not exceed one hundred seventeen thousand two hundred nine United States Dollars and fifty two Cents (US \$3117,209.52) for Lot #2 (Coupon), Alfa Centauri West Africa Limited for the supply of Pipes & Fittings ("the Goods") at an estimated cost to not exceed six hundred ninety-five thousand three hundred seventy-five United States Dollars (US \$695,375.00) and One Capital Group of Companies for the supply of Water Treatment Chemicals ("the Goods") at an estimated cost not to exceed One Million two hundred seventeen thousand nine hundred twenty-five United States Dollars (US\$ 1;217,925.00).

The Commission upon thorough review of additional documentation submitted reveals that the LWSC response to queries raised by the Commission is consistent with section 31 of the PPCA, 2010. Therefore, the Commission hereby grants an approval to the Liberia water and Sewer Corporation (LWSC) to award contracts to Conex energy, Alfa Centauri West Africa Limited and One Capital Group of Companies for the supply of the "Goods" at the estimated cost as indicated above.

Please note that all contract which cumulative annual value exceeds the threshold of two hundred fifty United States Dollars (US\$250,000:00) must be sign by the minister responsible for Finance and attested by the Minister Responsible for Justice. The Commission requires that you kindly forward copies of all stipulated contracts upon signing so as to update our records.

The Public Procurement and Concessions Commission admonishes and deems it a priority that you remain primarily in compliance with the PPCA, 2010, as we jointly aspire to achieve transparency, accountability, fairness, equality and ultimately public confidence in our procurement and concessions processes.
