
We present our compliments and wish to acknowledge receipt of your communication requesting the Commission's approval as indicated above.

The Government of Liberia, through the Ministry of Public Works, seeks approval for the adoption of the Single Source Procurement Method to engage **Pavifort Al Associate Inc.** for a concession contract related to the development of 313Km of primary roads across four (4) counties in Liberia. This initiative is critical to enhancing regional connectivity, fostering economic growth, and improving access to essential services.

**Project Scope and Justification**

The proposed project covers the conduct of a design study, development of detailed engineering design scheme, technical specifications, and the identification and sourcing of external financing for the construction of the following road corridors:

- 1) St. Paul Bridge – Klay (37.5Km)
- 2) Klay – Bo Waterside (79Km)
- 3) Klay – Tubmanburg (22Km)
- 4) Madina – Robertsport (30.5Km)
- 5) Brewerville – Bopulu (90Km)
- 6) Tubmanburg – Bopulu (54Km)
