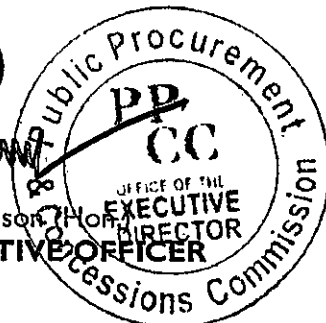

**Re: Letter of Intent seeking "No Objection" for MPW to award contract under Single Source Procurement Method for the Rehabilitation and Maintenance of Tappita - Zwedru (115KM) Road Corridor to China Hennah International Corporation**

I write to remind you that the above-mentioned road corridor was awarded to **LONG XIN WEI CONSTRUCTION ENGINEERING CO. LTD** under Single Source Procurement Method approved by the Public Procurement and Concessions Commission during the current regime's Hundred 100-Day Deliverable Projects procurement process under the caption **"No Car will get stuck in the mud on primary corridors" by the President of Liberia, HE Joseph Nyuma Boakai.**

After the contract award and subsequent commencement of the project, the contractor is not meeting the benchmark as specified in the scope of works with reference to the contractual agreement despite the issuance of warning letters which has compared the Ministry to consider said act as a breach of the contract. In lieu of this, the Ministry has opted to terminate the contract pursuant to Section 14 count (a), (c) and (e) of the herein mentioned contract with immediate effect as of the date of this request to remedy the situation.

In view of the foregoing, the Ministry of Public Works Procurement Committee likes to inform you of its decision and to seek your approval to Single Source the Rehabilitation and Periodic Maintenance Project of the remaining works on Tappita - Zwedru (115KM) Road Corridor under an Output-based Performance Road Contract (OPRC) for a period of One year from February 2025 to February 2026 for the contract amount of One Million One Hundred Twenty Thousand United States Dollars Twenty-Nine (US\$1,120,000.00).

The Ministry intends to Single Source this major thoroughfare to CHICO for the below listed reasons:

- ❖ The company recommended is legally registered and licensed under the laws of Liberia to carry out road construction works.
- ❖ The company is mobilized on Section two (2) of the corridor Zwedru - Karnweaken Junction (110km) for Two years' periodic maintenance and rehabilitation and excellently performing
- ❖ The company has the requisite equipment and technical experience to carry out the periodic maintenance intervention in line with the Contractual agreement.
- ❖ In spite of the company's experience in road rehabilitation and routine maintenance, the Ministry will assign experienced engineers to monitor and supervise the implementation of the project.
- ❖ The early award of this Contract to the above-mentioned Company for immediate intervention during this dried season which will enable citizens to travel to and fro in said corridor during the upcoming rainy season to enable also our international partners during site visits to road and other rural projects.
- ❖ Continuous intervention in the corridor will enable the citizens to move goods and Services to Counties Capitals and rural communities easily which will improve social and economic well-being of the surrounding communities and counties.

Now therefore, the Ministry seeks **"No Objection"** to award contract to the above-mentioned company.
