The Commission upon a thorough review of your documentation submitted is pleased to highlight the following:

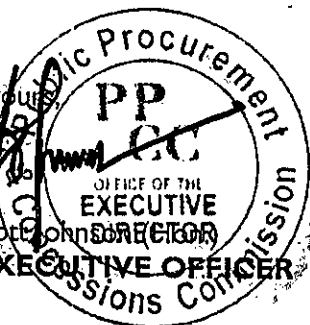
- ❖ The MPW submitted its approved procurement plan as Section 40 of the PPCA requires.

Re: Request for "No Objection" for Consulting Services for Preparatory Studies, Detailed Designs, Procurement Support, Works Supervision and Management of the Liberian Swedish Access Driven Rural Development Programme (LISA) Technical Assistant.

Kindly accept my compliments and best wishes.

I write to inform you that the Ministry of Public Works carry out request for proposal process for consulting service for Preparatory Studies, Detailed Designs, Procurement Support, Works Supervision and Management of the Liberian Swedish Access Driven Rural Development Programmed (LISA) Technical Assistant under contract package number RFP NO: MPW/LISA/PROJ/QCBS/001/24 using the Quality Cost Based Selection Method. An Ad-hoc evaluation panel was constituted for evaluation and recommended to the Procurement Committee.

Upon the completion of the evaluation, the panel recommended Cowater **International** in association with LIDA as joint venture partner for contract award with contract price of One Million Five Hundred Thirty-One Thousand Four Hundred Seventy-Two United States Dollars (1,531,472 USD).

Subsequent to the procurement committee's approval of the evaluation report, a negotiation with the firms was held for adjustment in time frame for the provision of service from 24 months to 17 months with a contract price of USD\$(942,586.00) which minutes is attached for your consideration.
