We present our compliments and wish to acknowledge receipt of your communication which sought the approval of the Commission for the Civil Service Agency's request for "No Objection" to single source New Technology Solution for the hosting of the CSA's Web Application at an estimated amount of US\$ 24,300.00 (Twenty-Four Thousand Three Hundred United States Dollars) for the fiscal year 2024.

The Commission upon thorough review of your request highlights the following:

- CSA did not submit a procurement plan for the Web Application Service as required by Section 40 of the PPCA.
- CSA did not submit a budget to support the Web Application Service procurement package as required by Section 72 of the PPCA of 2010.
- The legal qualification documents (tax clearance and business registration) submitted by New Technology Solution are invalid.

From the above-mentioned, the Commission Cannot grant the Entity's request for "No Objection" to single source New Technology Solution for the hosting of the CSA's Web Application service at an estimated amount of US\$ 24,300.00 (Twenty-Four Thousand Three Hundred United States Dollars) for the fiscal year 2024. Therefore, the Commission requests that the CSA address the query by resubmitting the indicated documents.

The Public Procurement and Concessions Commission admonishes and deems it a priority that you remain in compliance with the PPCA, 2010, as we jointly aspire to achieve transparency, accountability, fairness, equality, and ultimately public confidence in our procurement and concessions processes.
