# Subj: PROVISIONAL APPROVAL OF DRAFT PROCUREMENT PLAN FOR FISCAL YEAR 2024

We present our compliments and wish to acknowledge receipt of your communication which sought the approval of the Commission for the John F. Kennedy Memorial Medical Center Draft Procurement Plan. Following thorough review, the Commission hereby approves the JFKMMC's draft procurement plan for fiscal year 2024 in accordance with Section 40 (3) of the PPCA, 2010, and informs the JFKMMC that the procurement plan will be duly forwarded to the Ministry of Finance and Development Planning (MFDP), and that the MFDP will process allotments in keeping with the approved procurement plan. However, JFKMMC is advised to submit its annual procurement plan for final approval by the Commission following the passage of the National Budget. Also, the Commission requests that the JFKMMC submit the use of sole source procurement for the Commission's prior approval before awarding contracts in reliance with Section 55 (3) of the PPCA.

The Commission counsels that you observe Section 40 (5) of the PPCA, 2010, which states "each Procuring Entity, shall, on a quarterly basis and whenever it becomes necessary, review and update its procurement plans and notify the Commission in writing and the Minister of Finance of any material changes in its plan. However, an updated procurement plan shall accompany said notice to the Commission."

Please note that an approval of a method on the procurement plan is deemed as the Commission's full approval and as such a Procuring Entity will not be required to again request the use of said approved method.

The Public Procurement and Corcessions Commission admonishes and deems it a priority that you remain primarily in compliance with the PPCA, 2010, as we jointly aspire to achieve transparency, accountability, fairness, equality and ultimately public confidence in our procurement and concessions processes ocurement.
