1. Jhpiego is an international non-profit organization affiliated with Johns Hopkins University headquartered in Baltimore, Maryland, USA. For more than 40 years and in over 155 countries, Jhpiego has been a global leader in improving health care in developing countries and trains health professionals to prevent the needless deaths of women and their families. Jhpiego has been working in Liberia since 2008 and works closely with the Ministry of Health (MOH) in Liberia for building capacity in providing quality health services to the Liberian population.
2. Jhpiego Liberia has a requirement for three (3) service providers, on a standby basis, to provide **Vehicle Rental Services** on demand against pre-determined prices valid for one (1) year in the various counties listed in clause 9 of this RFQ.
3. This RFQ will establish a ranking list of potential Suppliers. The highest three suppliers will be awarded a Preferred Vendor/Blanket Purchase Order Agreement. The Suppliers will be selected based on their technical compliance, delivery time, service availability and total gross price. This approach will give Jhpiego Liberia access to a pool of “pre-qualified” service providers that can provide **Vehicle Rental Services** on an as needed basis.
4. Jhpiego Liberia invites quotations for **Vehicle Rental Services** as described in the **Schedule of Requirements**.
5. The responses to this RFQ will be evaluated according to
  - Technical conformity
  - Delivery time
  - Service Availability
  - Business registry and tax compliance
  - Valid Legal Documents for all Vehicles
  - Evidence of Insurance Policy on all vehicles
  - Qualified /licensed drivers
  - Price
  - At least two years experience.
6. A preferred vendor agreement will be issued to at least two highest ranked bidders. The highest ranked bidder will be Jhpiego Liberia “first choice” service provider and the 2<sup>nd</sup> and 3<sup>rd</sup> ranked Bidders will be used when necessary.
7. The Service Provider’s quotation, **including illustrated brochures (if necessary)**, must be delivered to the specified address on or before the submission date specified. Quotations will not be opened in public.
8. A draft BPO with Terms and Conditions is provided for your information. These documents must be studied and your quotation based on the contents as any ensuing award of contract will be based accordingly.
