## Invitation for Bids for the Procurement of Goods and Services

1. General Auditing Commission (GAC) is expected to receive commitment in the Government of Liberia's National Budget for Fiscal Year 2022 (January – December) and intends to apply part of it towards the procurement of goods and services in separate contract packages as indicated below.

8. Sealed bids must be delivered to the Procurement Unit not later than the time and date indicated in the bidding document.
9. Late bids will be rejected and returned to bidders unopened. Bids will be opened in the presence of bidders who choose to attend or their representatives on the time and date indicated in the bidding document in the Conference room of the GAC, on the 2<sup>nd</sup> floor.
