1. General Auditing Commission (GAC) is expected to receive commitment in the Government of Liberia's Approved National Budget for Fiscal Year 2021 and intends to apply part of it towards the procurement of goods and services in separate contract packages as indicated below.



5. Qualification requirements are:
 - Article of Incorporation
 - Valid Tax Clearance
 - Valid Business Registration Certificate
 - Past performance records- including the names and contact numbers of at least three clients.
 - PPCC vendors registration form
6. All interested eligible bidders may obtain copy of bidding documents when a written communication requesting for a copy(s) is submitted to the address below. The communication should include the name of the business, type of contract package, signature of authorized person and official stamp of the business. Copy of bidding document will be available from July 27, 2021 to August 10, 2021 from 9am to 4pm daily.
7. All bids must be accompanied by a **Bid Securing Declaration** in the format as indicated in the bidding document.
8. Sealed bids must be delivered to the Procurement Unit not later than the time and date indicated in the bidding document.
9. Late bids will be rejected and returned to bidders unopened. Bids will be opened in the presence of bidders who choose to attend or their representatives on the time and date indicated in the bidding document in the Conference room of the GAC, on the 2nd floor.


