The communication should include the name of the business, type of contract package, signature of authorized person and official stamp of the business. Copy of bidding document will be available from August 16, 2021 to August 27, 2021 from 9am to 4pm daily.
7. All bids must be accompanied by a **Bid Securing Declaration** in the format as indicated in the bidding document.
8. Sealed bids must be delivered to the Procurement Unit not later than the time and date indicated in the bidding document.
9. Late bids will be rejected and returned to bidders unopened. Bids will be opened in the presence of bidders who choose to attend or their representatives on the time and date indicated in the bidding document in the Conference room of the GAC, on the 2<sup>nd</sup> floor.
