Subject: **RESPONSE: CLARIFICATION ON "NO OBJECTION" FOR THE HOUSE OF REPRESENTATIVES (HOR) TO AWARD FRAMEWORK CONTRACT TO SUPER PETROLEUM FOR THE SUPPLY AND DELIVERY OF PETROLEUM PRODUCTS – FY 2020/2021**

We present our compliments and wish to acknowledge receipt of your letters (April 27, 28, 30, 2021) providing information and clarifications on the Commission's communication of **April 12, 2021**, relating to a **"No Objection" approval** for the HOR to award framework contract to Super Petroleum for the supply and delivery of petroleum products (Diesel and Gasoline coupons) under the Fiscal Year 2020/2021.

The Commission, upon review of the clarifications communicated by the HOR, and the accompanying documentations and explanations, and also relying on the House of Representatives assurances for compliance, hereby states the below:

- That **"No Objection"** is granted for the HOR to award a framework contract to Super Petroleum for a monthly amount not to exceed two hundred forty-three thousand five hundred fifty United States Dollars and eleven cents (US\$243,550.11), for Diesel and Gasoline coupons, for a period of six (6) months, in consonance with the stipulated amount (US\$1,461,301.00) for this contract package on the HOR's approved procurement plan.

Please note that this letter supersedes the Commission's prior communication of April 12, 2021, regarding the stipulated contract package for **fuel and lubricants**.

The Public Procurement and Concessions Commission admonishes and deems it a priority that you remain **primarily** in compliance with the PPCA, 2010, as we jointly aspire to achieve transparency, accountability, fairness, equality and ultimately public confidence in our procurement and concessions processes.

**Subject: Clarification on the \$1,461,301 Budget for the Honorable House of Representatives Petroleum Products**

Dear Atty. Kowo:

Compliments!

I am pleased to inform your Office and herewith to provide you the following clarification regarding the House's **\$1,461,301** budget for Petroleum Products.

- Although during our submission, we did not submit source document that the stipulated amount on the Procurement Plan and the Budget were not meant for twelve months, instead of six months.
- Because of that, the monthly threshold of **Two Hundred and forty-three thousand Five Hundred and Fifty United states dollars Sixteen cents (USD \$243,550.16)** for the Six period was understated by **One Hundred and Twenty-one Thousand Seven Hundred and Seventy-Five United States Dollars Eight Cents (\$ USD121,775.08)**
- That the amount above mentioned in the first paragraph, is less than our previous budgets for Petroleum products.
- See attached summary budget from the Ministry of Finance and Development Planning and also two copies of previous approved Procurement Plan to sustain the clarification.

With the above clarification, we request your office to interpose '**No Objection**' in order to proceed with the processes of our gasoline payment voucher at the Ministry of Finance Development Planning.
