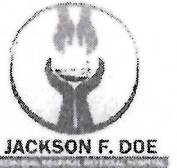



Subject: **PPCC RESPONSE: REQUEST FOR "NO OBJECTION" TO AWARD CONTRACT TO LUCKY DEVELOPMENT CORPORATION PHARMACY FOR MEDICAL DRUGS SUPPLY AND G2 PHARMACY FOR MEDICAL CONSUMABLES (LOTS 1 AND 2) - FISCAL YEAR 2022**

We present our compliments and wish to acknowledge receipt of letter and accompanying documents, which sought the approval of the Commission for the Jackson F. Doe Memorial Hospital to award contract to **Lucky Pharmacy** for the supply and delivery of Medical Drugs at a cost of **US\$75,966.25** and **G2 Pharmacy** for the supply of Medical Consumables (Lots 1 and 2) at a cost of **US\$25,589.60** and **US\$116,758.00**, respectively.

The Commission, upon review of your submissions, highlights the following:

- That the Jackson F. Doe Memorial Hospital submitted (**Hard copies**) including: bid documents, bid evaluation report, procurement committee meeting minutes, bid opening minutes, draft contracts, etc.
- That JFDMH instituted the Restricted Bidding (RB) method of procurement for both contract packages (Medical Drugs and Consumables), and three (3) out of five (5) suppliers submitted bids (Lucky Pharmacy, Indian Pharmacy and G2 Pharmacy);

That as per the JFDMH's BEP Report, **Lucky Pharmacy and G2 Pharmacy** were deemed responsive to stipulated requirements for the supply of **Medical Drugs** and **Medical Consumables** (Lots 1&2), respectively.

Thus, the Commission upon overall scrutiny of JFDMH's submissions and accompanying documents, hereby states below:

- That a "**No Objection**" is rendered for the Jackson F. Doe Memorial Hospital to award contract to **Lucky Pharmacy** for the supply of **Medical Drugs** in the stipulated amount of **US\$75,966.25** and **G2 Pharmacy** for the supply of **Medical Consumables** (lots# 1&2) in the combined total amount of **US\$142,347.60**.

Please note that all contracts which cumulative annual value above the threshold of **US\$250,000.00** must be signed by the Minister responsible for Finance and attested to by the Minister responsible for Justice. **The Commission requires that you kindly forward copies of all stipulated contracts upon signing, so as to update our records.**

The Public Procurement and Concessions Commission admonishes and it a priority that you remain primarily in compliance with the PPCA, 2010, as we jointly aspire to achieve transparency, accountability, fairness, equality and ultimate public confidence in our procurement and concession processes.
