## Invitation for Bids (IFB)

### INTERNATIONAL COMPETITIVE BIDDING FOR THE

#### Procurement of Uniform & Specialized Clothing

(IFB.LNP/ICB/001/14/15)

1. The Liberia National Police (**has set aside public funds**) received from Government of Liberia's fiscal allotment to payments under the contract for Procurement of **Uniform & Specialized Clothing IFB.LNP/ICB/001/14/15 (including boots and all uniform accessories)**, toward the realization of the above mentioned project.
2. The Liberia National Police now invites sealed bids from eligible and qualified bidders for supply of **Uniform & Specialized Clothing**.
3. Bidding will be conducted through the International Competitive Bidding (ICB), a procedure specified in the PPCA and approved by the PPCC, and is opened to all bidders from Eligible Source Countries as defined in the Guidelines.
4. Interested eligible bidders may obtain further information from Liberia National Police; ACP. Darlington H. Williams, e-mail: [wilddarlington@yahoo.com](mailto:wilddarlington@yahoo.com) and inspect the Bidding Documents at the address given below from 9:30 am - 4:00 pm beginning October 21, 2014.
5. A complete set of Bidding Documents in English may be purchased by interested bidders on the submission of a written Application to the address below and upon payment of a nonrefundable fee of One Hundred and fifty United State Dollars (US\$150.00). Interest Bidder made make payment for the bidding documents at the Liberia National Police Procurement Section (**Basement # 2**).
6. Bids must be delivered to the address below on or before December 2, 2014 at 11:00 AM **local/Liberian time**. Electronic bidding will **not be** permitted. Late bids will **be rejected**. Bids will be opened in the presence of the bidders' representatives who choose to attend in person at the address below on December 2, 2014 at 11:15 AM **local/Liberian time**.
7. Bidding will be conducted through International Competitive Bidding (ICB) procedures, and the qualification criteria to be strictly ahead to by all bidders are indicated in section II and section III of the bidding documents. Detailed technical specification for all the items of the schedule included in the IFB are contained in a single bidding document. Bidder need not purchase more than one set of bidding document. Bidders are required to quote for all of the schedule.
8. All bids must be accompanied by a Bid Security in **USD\$3,660.00** or in a freely convertible currency acceptable to the purchaser, and in an irrevocable Bank Guarantee valid for One

Hundred and Twenty (120) days from the date of bid submission in favor of the Liberia National Police.
