Subject: **"NO OBJECTION" TO USE FRAMEWORK CONTRACT AGREEMENT TO AWARD CONTRACT TO SUPER PETROLEUM FOR THE SUPPLY AND DELIVERY OF PETROLEUM PRODUCTS FOR FISCAL YEAR 2022**

We present our compliments and wish to acknowledge receipt of your letter which sought the approval of the Commission for the Ministry of Finance and Development Planning (**MFDP**) to award a framework contract to Super Petroleum for the supply and delivery of petroleum products in the amount of five hundred fifty-three thousand seven hundred twenty-four Unites States Dollars and twenty-three cents **US\$553,724.23**.

The Commission, upon review of your submissions, highlights the following:

- That the Ministry of Finance and Development Planning submitted (**Hard copies**) including: bid documents, bid evaluation report, procurement committee meeting minutes, bid opening minutes, etc.;
 - That MFDP's submissions Report indicates that eight (8) companies received invitations to participate in a restricted bidding process and only Super Petroleum Corporation submitted bid;
 - That MFDP's BEP Report shows that Super Petroleum Corporation was deemed the most responsive to the preliminary, technical and financial evaluation.

The Commission, upon overall review of your submission renders "No Objection" for the **Ministry of Finance and Development Planning** to award a framework contract to **Super Petroleum Corporation** for the supply of the goods as indicated above and in the stipulated monthly amount not to exceed forty-six thousand one hundred forty-three United States Dollars and sixty-nine cents **US\$46,143.69**

Kindly be reminded that all contracts which cumulative annual value exceeds the threshold of **US\$250,000.00** must be signed by the Minister responsible for Finance and attested to by the Minister responsible for Justice.

The Public Procurement and Concessions Commission admonishes and deems it a priority that you remain, **primarily**, in compliance with the PPCA, 2010, as we jointly aspire to achieve Transparency, Accountability, Fairness, Equality and ultimately public confidence in our procurement and concessions processes.
