We extend sincere compliments and write your Commission to grant us no objection to Award Contract for the procurement of sixteen (16) vehicles to Alliance Motor Company by the Ministry of Internal Affairs in compliance with section 31 of the PPCA. The procurement of fifteen (15) vehicles will be used by the Counties' Superintendents for smooth operation of their offices and one (1) vehicle will be used by the office of the Minister.
