Request for No Objection to Award Contract to Jungle Water Group of Investment for the Supply and Delivery of Assorted Building Materials for the Nimba County Health Team/MOH with Funding from FARA/USAID

I am pleased to present my compliments and herewith request the Public Procurement Commission's "No Objection" to award contract to Jungle Water Group of Investments for the supply and delivery of assorted building materials to the Nimba County Health Team (NCHT) of the Ministry of Health to support health system strengthening for fiscal year 2022, with funding from the Fixed Amount Reimbursement Agreement (FARA).

For your information, this procurement process was conducted using the National Competitive Bidding Method (NCB). The bidders were invited through an open media publication (Newspapers) as required by the PPCC. At the date of submission, four (4) firms responded to the tender for both lots and only one firm (Jungle Water Group of Investments) was evaluated by a team of independent evaluation panelists as "most responsive".

The Ministry of Health intends to award said contract to Jungle Water Group of Investment in the amount of Four Hundred Thirty Thousand One Hundred Five 15/100 United Stated Dollars (\$430,105.15). Kindly not that your approval is critical to the MOH achieving it goals.


