Subject: REQUEST FOR "NO OBJECTION" TO AWARD CONTRACT TO GREENFIELDS-A TENCATE GRASS COMPANY FOR THE SUPPLY AND INSTALLATION OF ARTIFICIAL TURF ON THE SAMUEL KANYON DOE SPORTS PITCH.

We present our compliments and wish to acknowledge receipt of your letter, which sought the approval of the Commission for the Ministry of Youth and Sports to award contract to Greenfields-A Tencate Grass Company for the supply and installation of synthetic Turf at the SKD Sport Complex in the amount of **US\$729,500.00 (seven hundred twenty-nine thousand five hundred United States Dollars)**.

- That MYS submitted (hard copies): bid documents, bid evaluation report, procurement committee meeting minutes, bid opening minutes, etc.
- That MYS instituted an ICB process, and only one company submitted, as per MYS's submissions.

2. That MYS should ensure quality conformance given the nature of this Contract Package.

Additionally, the MYS is reminded that all contracts which cumulative annual value exceeds the threshold of US\$250,000 must be signed by the Minister responsible for Finance.

The Public Procurement and Concessions Commission admonishes and deems it a priority that you remain primarily in compliance with the PPCA, 2010, as we jointly aspire to achieve transparency, accountability, fairness, equality and ultimate public confidence in our procurement and concession Processes.


Dear Honorable Kowo:
