We present our compliments and wish to acknowledge receipt of your letter, which sought the approval of the Commission for the Ministry of Youth and Sports to use the Sole Source method of procurement to hire a consultant for the conduct of a quick impact assessment of all "At-Risk-Youths" in Liberia.

The Commission, upon review of the MOYS' request, observed the following:

- That the MOYS provisionally approved procurement plan for Fiscal Year 2020/2021 does not include the aforementioned contract package or any for consultancy;
- There is no evidence of source of funding for this procurement.

The Commission, noting these observations, advises the MOYS to promptly address the issues as indicated above, to facilitate an informed decision.

The Public Procurement and Concessions Commission admonishes and deems it a priority that you remain **primarily** in compliance with the PPCA, 2010, as we jointly aspire to achieve transparency, accountability, fairness, equality and ultimately public confidence in our procurement and concessions processes.
