Subject: **"NO OBJECTION" TO USE FRAMEWORK CONTRACT AGREEMENT TO AWARD CONTRACT TO SUPER PETROLEUM FOR THE SUPPLY AND DELIVERY OF PETROLEUM PRODUCTS (DIESEL-BULK/GASOLINE-COUPONS) FOR FISCAL YEAR 2022.**

We present our compliments and wish to acknowledge receipt of your letter which sought the approval of the Commission for the **National Transit Authority (NTA)** to award a framework contract to Super Petroleum for the supply and delivery of petroleum products in the amount of one million seven hundred thirty seven thousand one hundred seventy United States dollars and fifty six cents **USDS\$1,737,170.56** for bulk fuel (Diesel) and Coupons (Gasoline).

The Commission, upon review of your submissions, highlights the following:


- That the National Transit Authority submitted (**Hard copies**) including: bid documents, bid evaluation report, procurement committee meeting minutes, bid opening minutes, etc.;
- That NTA's BEP Report indicates that two (2) companies participated in the bidding process (Aminata and Sons, Inc., and Super Petroleum Company);
- That NTA's BEP Report shows that Super Petroleum Company was deemed the most responsive at the financial evaluation stage.

The Commission, upon overall review of your submission renders "**No Objection**" for the **National Transit Authority** to award a framework contract to **Super Petroleum Company** for the supply of the goods as indicated above and in the stipulated monthly amount not to exceed one hundred forty-four thousand seven hundred sixty-four United States dollars and twenty-one cents **US\$144,764.21**

Kindly be reminded that all contracts which cumulative annual value exceeds the threshold of **US\$250,000.00** must be signed by the Minister responsible for Finance and attested to by the Minister responsible for Justice.

The Public Procurement and Concessions Commission admonishes and deems it a priority that you remain, **primarily**, in compliance with the PPCA, 2010, as we jointly aspire to achieve Transparency, Accountability, Fairness, Equality and ultimately public confidence in our procurement and concessions processes.

Subject: NOTIFICATION OF INTENT TO AWARD CONTRACT FOR FUEL AND GASOLINE


We present our compliments and consistent with the Amended & Restated Public Procurement and Concessions Act of 2010 Section 31 (Contract above US\$250,000), we wish to notify you of our intent to award a frame work contract to **SUPER PETROLEUM (SP) COMPANY**, to supply Petroleum Products [Diesel Fuel in Bulk] and [Gasoline in Coupons] to the National Transit Authority over a period of Nine (9) months (March-December) FY 2022. The Contract value amount is **One Million Six Hundred Forty Two Thousand Seven Hundred Eighty Eight 56/100 Cents (US\$1,642,788.56) United States Dollars** for the supply of **Three Hundred Eighty Four Thousand Seven Hundred Twenty Eight (384,728 gals.)** gallons of bulk diesel fuel including transportation cost and **Ninety Four Thousand Three Hundred Eighty Two Thousand (US\$94,382.00) United States Dollars** for the supply of **Twenty Three Thousand Twenty (23,020gals.)** gallons of gasoline in coupons.

Madam Executive Director, our decision to notify you of our intent to award contract to **SUPER PETROLEUM (SP) COMPANY**, resulted from a thorough bid evaluation process of which **SUPER Petroleum Company** was selected. When approved, Super Petroleum Company will supply and deliver 384,728 gallons of diesel fuel in bulk and 23,020 gallons of gasoline in coupons; the summation of the two petroleum products amounts to **US\$1,737,170.56 (One Million Seven Hundred Thirty Seven Thousand One Hundred Seventy 56/100 cents) United States Dollars**.

We like to emphasize that fuel is the life blood of public transportation and in the spirit of the Law; your approval will help the entity achieve its mandate to provide effective, efficient and affordable public transportation to commuters in Liberia.
