1. The Rural and Renewable Energy Agency (RREA) has received Funding from the Government of Liberia towards the cost of **Rural Street Lightening within five (5) Counties** and intends to apply part of the proceeds for payments under these contracts;

Supply, Installation and lighting of Street lights in Bong, Mary Land, Grand Bassa, Lofa and Grand Gedeh Counties

2. The **Rural and Renewable Energy Agency (RREA)** now invites sealed bids from eligible and qualified bidders for the above-mentioned Project described as in the Schedule of Requirement of the Bid Document.
3. Bidding will be conducted through the international Competitive Bidding (ICB) procedure as specified in the Government of Liberia's Public Procurement and Concessions Commission Act and Regulations (PPCA) and approved by the PPCC, and are open to all eligible bidders as defined in the PPC Act.
4. Interested eligible bidders may obtain further information from the Rural and Renewable Energy Agency and inspect the Bidding Documents at the address given below from 0900 to 1700 hours, Monday to Friday, excluding public holidays. 5. Bidding qualifications requirements include:
 - a) Business Legal/Registration documentation
 - b) Tax Clearance for domestic bidders for local companies
 - c) PPCC Vendor Registration Certificate for local companies
 - d) Notarized Power of Attorney
 - e) Audited Financial Statements for 2020 and 2021

6. A complete set of Bidding Documents in English may be purchased by interested bidders on the submission of a written Application to the address below and upon payment of a non- refundable fee of **USD\$50.00**. The method of payment will be a direct payment at RREA's Finance Department.
7. Bids must be delivered to the address below at or before **10:00 am** Local time, on **June 3, 2022**. Electronic bidding will not be permitted. Late bids will be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend in person at the address below at **10:00 am** on **June 3, 2022**. All bids must be accompanied by a **Bid Securing Declaration** to be completed using the form provided in the bid documents.
