RE: PUBLICATION OF NOTICE OF COMPLAINT /APPEAL

The Public Procurement and Concessions Commission (PPCC) hereby notifies all Individual Consultants, and Stakeholders that participated in the procurement process titled **“Invitation to Apply for Consultancy Services for the Development of Procurement Regulations and Related Instruments”** under **Reference (No. LR-PPCC-497947-CS-INDV)**, that a **Complaint/Appeal** has been filed with the **Complaints, Appeals and Review Panel (CARP)** by **Cllr. Emmanuel A. Tulay, Sr.**, represented by **Tulay & Associates Law Offices, Inc.**, in keeping with **Part VIII, Section 125 (1) (a) and (b) of the Amended and Restated Public Procurement and Concessions Act, 2010**.

In his Complaint/Appeal, the Complainant alleges that the **Head of the Public Procurement and Concessions Commission** wrongfully refused to hear and investigate his procurement complaint, as communicated in a decision dated **December 29, 2025**, thereby denying him **administrative due process** contrary to **Sections 125(1), 125(2), and 125(6) of the PPCC Act, 2010**, the **Administrative Procedure Act**, and **Article 20 of the 1986 Constitution of Liberia**.

The Complainant further avers that he duly participated in the bidding process and was initially notified that he ranked **second** following the withdrawal of the first-ranked candidate, but was subsequently informed that he had been re-ranked **third**, under circumstances he alleges involved **fraud, undue influence, conflict of interest, and coercion** in the evaluation process. The Complainant contends that the procurement process was unlawfully altered and that the refusal of the PPCC to investigate his complaint was arbitrary, illegal, and inconsistent with governing procurement laws of Liberia.

In view of the foregoing allegations, the Complainant has filed this action before CARP, **praying for the reversal of the PPCC’s decision in the selection and award of the aforesaid mentioned consultancy**, and is further requesting the immediate **suspension or stay** of the procurement proceedings until the matter is heard and determined, pursuant to **Section 129 of the PPCC Act, 2010**.

All participating individual consultants, or other parties who may be affected by the resolution of this Complaint/Appeal are hereby requested to **file their Notice of Appearance** with the **Complaints, Appeals and Review Panel (CARP)** within **seven (7) days** of the publication of this Notice, declaring an interest to appear and be heard, in keeping with **Section 126(9) of the PPC Act, 2010**.




