## **RE:** Publication of Notice of Complaint

The Public Procurement and Concessions Commission (PPCC) hereby notifies bidders that participated in the Ministry of Post & Telecommunications, (MOPT) procurement for seven (7) motorbikes that a Complaint/Request for Review has been filed by the Ministry of Post & Telecommunications (MOPT), with the PPCC in keeping with Section 125.1 (a)(b) of the Public Procurement and Concessions Act (PPCC, 2010).

In its complaint, the Ministry of Post & Telecommunications, (MOPT), alleges the following:

- 1. That the PEEKAY Enterprises violated Part I, (f) & (g), of the PPC Act 2010, when it failed to deliver seven (7) procured motorbikes to the Ministry thus questioning its level of integrity, fairness and transparency as required by the PPC Act 2010.
- 2. That PEEKAY Enterprise grossly violated Section 132. (1) when it failed to abide by its obligations under the PPC Act, 2010 and by extension the contract signed with the Ministry of Post & Telecommunications for the provision of the stated number of motorbikes.
- 3. That the Ministry of Finance and Development Planning (MFDP), on behalf of the Ministry of Post & Telecommunications made two separate payments to PEEKAY Enterprises on check numbers: 0025733 and 0025732 bearing the amounts of 531,749.90 and 783,476.63 Liberian Dollars, respectively, and the total of L\$1,315,226.53.
- 4. That PEEKAY Enterprises, having taken delivery of the checks bearing the stated amounts, refused to deliver the motorbikes despite persistent engagements with it (PEEKAY Enterprises).
- 5. That the Office of the Executive of the PPCC was requested to intervene in the matter and to have PEEKAY Enterprises deliver on its obligation. After couple of meetings with the Ministry of Post & Telecommunications and PEEKAY Enterprises under the auspices of the PPCC Executive Director, PEEKAY Enterprises, through its Representative and Legal Counsel admitted to receiving the money and committed to delivering the seven (7) motorbikes.
- 6. That having committed to delivering the said motorbikes, PEEKAY Enterprises has refused to deliver same.
- 7. That PEEKAY Enterprises continual refusal to deliver the said motorbikes to the Ministry of Post & Telecommunications has stalled the Ministry's operation thus impeding its deliverables for which it is seeking redress.

In view of the above, the Ministry of Post & Telecommunications has filed this action, praying for CARP's investigation of the matter, and to compel PEEKAY Enterprises to deliver the motorbikes in question, and to take any further actions deemed necessary, just and equitable on PEEKAY Enterprises consistent with the PPC Act, 2010.

Other participating bidders who may be affected by the resolution of this complaint, are requested to file their notice of appearance with the Complaint Appeals and Review Panel (CARP) within seven (7) days, upon publication of this Notice by the Commission, declaring an interest to appear at the hearing in keeping with Section 126(9).
