## Introduction

The Public Procurement & Concessions Commission has developed this Public Procurement Contract Package Directory to guide procuring entities and to facilitate a consistent approach of deriving and describing contract packages to be captured in their annual procurement plans, so as to ensure that annual planning is conducted in a standardized and uniform manner across procuring entities.

This Public Procurement Contract Package Directory (PPCPD) was developed based on the contents of the Government of Liberia's National Budget, Chart of Accounts (COA Version 2.3, July 2013) and International Standard Industrial Classification of all Economic Activities (ISIC) Rev.4.

The purpose of this PPCPD is to guide public procurement practitioners in planning their respective procurement activities in an accurate and realistic manner for the procurement of goods, works and services.

The objectives of this directory are as follows:

- To ensure consistency in procurement planning across national government;
- To eliminate contract splintering and spilt procurement in annual procurement planning and
- To prepare a realistic and implementable annual procurement plan

**Note:** Please note that this directory is not exhaustive, thus from time to time it will be updated to accommodate contract packages that are not captured in it for now. Also, it does not include contract packages that are peculiar to some procuring entities. The Compliance and Monitoring Division of the Commission will continue to work closely with those entities and provide the necessary technical assistance to ensure appropriate coding of any unique package not contained in this directory.

### **“Depicting The Relationship Between Budget Lines and Contract Packages”**

It’s a known fact that not all budget lines can be duplicated into a contract package, thus by duplicating a budget line that can’t be executed as a contract package makes it difficult for public procurement activities to be done in an effective and efficient manner. To this end, budget lines that can’t be duplicated as contract packages should be treated as follows:

#### **Treatment:**

#### **Budget lines:**

- a. Telecommunication, Internet, Postage & Courier;
- b. Workshop, Conferences & Symposium;
- c. ICT infrastructure, Hardware, Software, and Networks;
- d. Celebration, commemoration and gifts;
- e. Entertainment representation and gifts

The above budget lines shouldn’t be captured in the annual procurement plan as prospective contract package because they are not objects of procurement, in that they have several procurable inputs conglomerated under them, thus in order to capture the procurable inputs of these budget lines in the procurement plan, the procurable inputs must first be fleshed out as indicated in the example below:

- o **Telecommunication, Internet, Postage & Courier-----US\$100, 000, 00.**

#### **Procurable inputs:**

- a. Scratch Cards-----US\$25,000.00
- b. Internet connectivity-----US\$20,000.00
- c. Caller user group services-----US\$25,000.00



- d. Postage Services-----US\$15,000.00
- e. Courier Services-----US\$15,000.00

**Note:** Only procurable items should be captured in the procurement plan, with accompanying explanatory notes provided in the explanatory notes matrix to state for example that the procurable item is from the budget line Telecommunication, Internet, Postage and Courier, and is intended to procure XYZ.

**In a nutshell, unrelated contract packages being funded by one budget line should be treated as a single contract package.**

Furthermore, related contract packages being funded by different budget lines should be aggregated into a single contract package in the procurement plan, so as to avoid split procurement and contract fragmentation.

For example, stationery and training materials to be procured from the budget line **'Workshop, Conferences and Symposium'** to facilitate workshops should be added to the contract package **'Stationery & Supplies'**, with an explanatory note provided in the explanatory notes matrix stating that **US\$XX** from the budget line **'Workshop, Conferences and Symposium'** for the procurement of **stationery and training materials for workshop** has been added to the **total appropriation** of **'Stationery & Supplies'**, thus increasing the estimated cost of the contract package from **US\$XXX** to **US\$XXX**.

Similarly, **'Food & Catering Services'** to be procured from the budget line **'Workshop, Conferences and Symposium'** to facilitate workshops should be added to the contract package **'Food & Catering Services'**, with an explanatory note provided in the explanatory notes matrix stating that **US\$XX** from the budget line **'Workshop, Conferences and Symposium'** for the procurement of **'Food & Catering Services'** for workshop has been added to the total appropriation for **'Food & Catering Services'**, thus increasing the estimated cost of the contract package from **US\$XXX** to **US\$XXX**.
