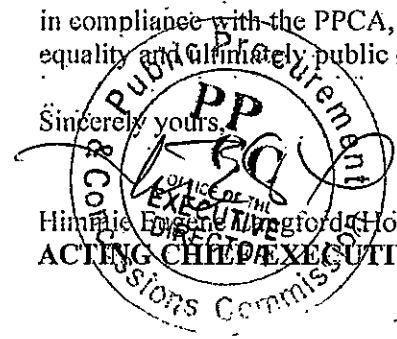

Dear Hon. Johnson:

Request for No Objection to Use Single Source Selection for the Acquisition of One 250KVA Generator

I present my compliments and herewith request the Commission's **No Objection** for the use of Single Source Selection Method for the procurement of generator to meet today's demand for power due to the inconsistency of the national power grid.

For your consideration, I present you facts and justification for the use of Single Source Selection Method, consistent with PPCA, section 50-(a), which states "*When the goods, works or services are only available from a limited number of bidders;*" and Section 55 (1) (e) "*When the services require that a particular consultant be selected due to his or her unique qualifications, or when it is indispensable to continue with the same consultant.*"

Background

The power outage from the national grid due to the dry season has led to the constant use of generator as the main source of power at the Redemption Hospital. As such, the hospital continued to experience breakdown in the 250 KVA generator due to its reduced life span. This generator has been with the hospital for more than eleven (11) years and it has over reached the usefulness. With one generator supplying the hospital that is serving as the only referral hospital for more than two hundred thousand Liberians, the hospital is under pressure to ensure conducive working conditions for its staff and patients.

The need to have another generator, which will replace the existing one, is even more urgent especially now that the city and its environs are experiencing power outages again. Meanwhile, our market survey has proven that generators of this capacity and size can be sourced from limited suppliers on the Liberian market.

MOH Recommendation

Findings from our market survey shows that **H&A Corporation**, is the only supplier that has the capacity in stock for now. Hence, the Ministry seeks your approval to use Single Source Selection for the acquisition of one set of 250KVA generator.
